## 1. Previous Minutes

# 2. Outstanding business

a. Overview of the new season

Due to the COVID-19 restrictions the new 2020 season has been changed dramatically. There will be a 10 week competition, with 3 separate precincts. Only one spectator per player will be allowed to maintain numbers. While all junior teams elected to play, the senior teams were condensed from 5 to 3. Borrowing policy is technically allowed, but players are only able to play one game per Saturday. Casual players are allowed however. Movement between precincts is restricted, if you are umpiring in one and playing

in another, you must remove layers/change clothes and wipe down before entering the new precinct. NNA will have a lanyard system to control numbers. There will be 18 minutes between games to ensure separation. For more complete information, please review <u>http://newcastlena.nsw.netball.com.au/</u> and the COVID-19 resources.

- b. Financial Position and Refunds (Treasurer's Report, please see attached)
  - i. \$20 Refund Policy finalise by next week (31<sup>st</sup> July) Previously agreed by executive (28.6.20) that we can offer a \$20 refund for those who need it.

### 3. New Business

a. COVID-19 Safety Requirements :

A reminder that all current requirements for training and games are on NNA COVID-19 Resources tab (<u>http://newcastlena.nsw.netball.com.au/</u>)and Netball NSW. Isobel Stoodley is the COVID-19 Officer for the club. Isobel did a briefing with Junior and Senior coaches before training commenced. Isobel can be contacted for any questions about the restrictrions.

At this stage our club duties are manning the Parkway avenue side entry and exit point on rounds 1, 2, 6 and 7. Six WNC people are required. Agreed to ask all teams and parents, Isobel and Nicole to organize the roster.

b. Goldies and Umpiring

A number of parents would not allow their child to partake in umpiring, on the increased risk of COVID-19. Only 3 players were willing to umpire. There was also noted resistance to paying for umpires. At this stage paid umpires will assist and those willing to umpire will umpire more. Coaching Convenor concerned about the resistance to umpiring and it's ongoing effects past this season. It was noted that only some of the team attended the NNA Umpiring program prior to the season. Nicole suggested they umpire the sub-juniors (who have to provide

their own umpires) to build confidence. Veronica (coach of Goldies) said she would pass on that option.

*c.* Grassroots Sports Fund
 Discussed various essential equipment that could be reimbursed or purchased, including balls, sanitizer and pinnies. Executive to complete application.

#### 4. General Business

a. Fundraising

b. Social Media

Discussed content for social media. Coaches and managers encouraged to contact players regarding player profiles. Team photos to be avoided at this stage.

c. Empower Play

Jane and David went to a Zoom meeting on Empower. It has been reworked for Zoom not face to face. 9-12 year olds. Up to coaches how much they want to use it. David said hard to organize. Only 2 players were interested in his team. Baulkham Hills Association said Empower helped increased players and sponsorship deals. No action required at this stage.

- d. Policies : Annual Awards Policy and Life Membership Policy Nick was tasked to update these two policies, with the addition of the Junior Person to the Annual Awards Policy and moving the Life Membership Policy to reflect similar policy at NNA. David moved they be accepted, Isobel seconded.

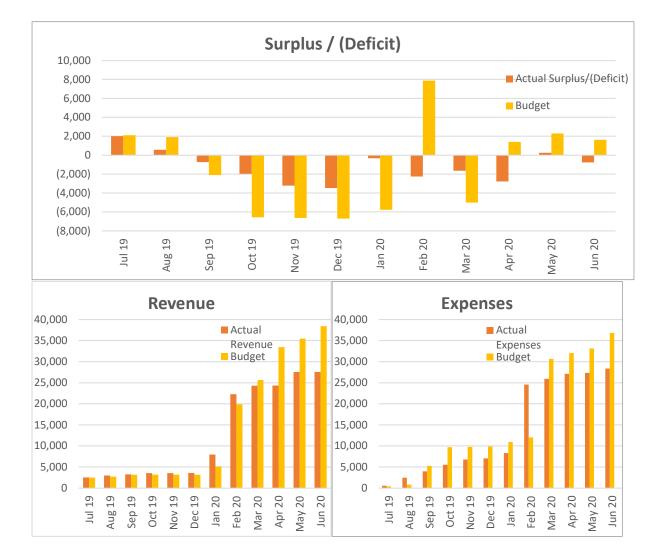
g. Senior Drinks Nicole to discuss with Terry from MWBC whether this can go ahead. Action: Nicole

#### <u>Notes</u>

#### VARIANCES

At the end of June we had \$11,645 in the bank. This is \$2,386 worse than we had budgeted and our current result of a deficit of \$764 is also \$2,386 worse than budget. The main drivers in this result are:

- We spent \$1,016 on balls in June
- We have not received the sponsorship (\$3,000) from the Bowling Club
- No further (after the Waratah shopping centre BBQ) fundraising activities have taken place this season.

#### 2020/21 Budget

Below is the budget. I have assumed:

- Fundraising of approx. \$2,000 less than a normal year, given the pandemic
- \$1,200 negative impact from refunds
- Nil increase in fees from NNA
- Nil increase in our fees, except for U23s, which I have assumed a \$15 increase to \$180.
